CONSTITUTIONAL AMENDMENT
ARTICLE VII, SECTIONS 3 AND 4
ARTICLE XII, SECTION 34**

**Solar Devices or Renewable Energy
Source Devices; Exemption From
Certain Taxation and Assessment**

Proposing an amendment to the State Constitution to authorize the Legislature, by general law, to exempt from ad valorem taxation the assessed value of solar or renewable energy source devices subject to tangible personal property tax, and to authorize the Legislature, by general law, to prohibit consideration of such devices in assessing the value of real property for ad valorem taxation purposes. This amendment takes effect January 1, 2018, and expires on December 31, 2037.

Want to Vote By Mail?

For your convenience, any registered voter may vote by absentee ballot. A voter, member of the voter's immediate family or legal guardian may request an absentee ballot in person, by mail or by telephone. One request can cover all elections through the next two regularly scheduled general elections.

Call the Elections Office at (850) 892-8112. All voted absentee ballots must be in the Supervisor's Office by 7 p.m. on Election Day, in order to be counted.



SIGNATURE UPDATE

Any time there is a change in your signature or identifying "mark", you must complete a new registration application & submit it to the Elections Office. If your signature on your voter record and the signature on your absentee ballot do not match, your absentee ballot will not count.

All polling locations provide disability compliant voting equipment.

It is a felony to vote in a precinct in which you do not reside. If your address has changed, please contact the Elections Office BEFORE you go to the polls to vote, so we can save you time!

HOW TO MAKE YOUR VOTE COUNT

Our tabulation system uses an optical scanner to read your ballot.

You must completely fill in the oval for your vote to count.

Please, do **not** use a check mark; do **not** mark the oval with an X; and do **not** circle the oval.

Florida is a closed primary state. In primary elections, registered voters can only vote for their registered party's candidates in a partisan race on the ballot. In a primary election, all registered voters, regardless of party affiliation, can vote on any issues, nonpartisan races, and races where a candidate faces no opposition in the General Election, such as a Universal Primary Contest. The deadline for new registrations and to declare party affiliation for the August 30th Primary Election is August 1, 2016 at 5:00 PM.
