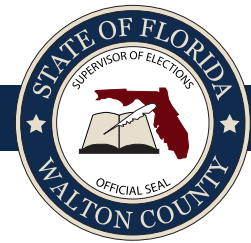


Walton County Supervisor of Elections, Bobby Beasley



Before requesting a Vote-by-Mail ballot, it is important to know:

- ◆ The **voter must be registered** to vote in the state of Florida no later than 29 days prior to any Election Day.
- ◆ If you are a voter, or a family member or legal guardian of a voter, requesting for a **ballot to go to an address already on file**, you may make the request on-line at VoteWalton.com, in-person, or by contacting our office by phone.
- ◆ If requesting for a **ballot to go to an address NOT already on file**, a signed written request from the voter must be submitted, unless the voter is in the military, a military dependent, or overseas.
- ◆ If you are **in the military, a military dependent, or overseas**, you have the option of having your ballot sent earlier and/or by email. Please contact us to submit your request if this applies.
- ◆ The **ballot is mailed to the voter** about 30 days prior to each election if the address is within the US, and 45 days prior if the address is outside the US or if the voter record indicates military status. Please provide the address where you will be at this time.
- ◆ The **ballot cannot be held or forwarded** by the US Post Office, and if undeliverable, will be returned to the Elections Office. This action will cause all future Vote-by-Mail requests to be canceled until the correct address is provided.
- ◆ The **ballot must be requested** no later than 5:00 pm six (6) days prior to any Election Day.
- ◆ The **voted ballot must be received by the Elections Office** no later than 7:00 pm on Election Day.
- ◆ The status of a voted ballot may be tracked on-line at VoteWalton.com.
