# BY MAIL

## Want to Vote-By-Mail?

For your convenience, any registered voter may Vote-By-Mail. A voter, member of the voter's immediate family or legal guardian may request a Vote-By-Mail ballot in person, by mail or by telephone. One request can cover all elections through the next two regularly scheduled general elections.

Call the Elections Office at (850) 892-8112. A request for a Vote-By-Mail ballot to be mailed to a voter must be received no later than 5 p.m. on the <u>sixth</u> day before the election, on November 2, 2016 by the supervisor of elections. All voted Vote-By-Mail ballots must be in the Supervisor's Office by 7 p.m. on Election Day, in order to be counted.

### Signature Update

Any time there is a change in your signature or identifying "mark", you must complete a new registration application & submit it to the Elections Office. If your signature on your voter record and the signature on your Vote-By-Mail ballot do not match, your Vote-By-Mail ballot will not count.

### How To **MAKE YOUR VOTE COUNT**

Our tabulation system uses an optical scanner to read your ballot.

You must completely fill in the oval for your vote to count.

This is a "SAMPLE" Ballot for informational purposes only. Please study this sample ballot and use it as a guide for voting. This is not an "Official" ballot - DO NOT return this to the **Elections Office.** 

This sample ballot was prepared in accordance with Section 101.20, Florida Statutes, and furnished by the Elections Office of Walton County.



When voting in person, you must have a valid picture and signature identification. Your photo and signature may appear together in one document or on two separate documents. Acceptable forms of ID:

- Florida Driver's License
- Veteran Health ID
- Retirement Center ID
- Credit or Debit Card
- Florida ID Card issued by DHSMV
- Neighborhood Association ID
- Concealed Weapon License
- Government Employee ID

- Public Assistance ID
- U.S. Passport
- Student ID
- Military ID

**Note:** If you do not have proper ID, you must vote a provisional ballot. (Section 97.0535, Florida Statutes)

## **Voter's Bill of Rights**

### Each registered voter in this state has the right to:

- 1. Vote and have their vote accurately counted.
- 2. Cast a vote if he or she is in line at the official closing time of the polls in your county.
- 3. Ask for and receive assistance in voting.
- 4. Receive up to two replacement ballots if he or she makes a mistake prior to the ballot being cast.
- 5. An explanation if their registration or identity is in question.
- 6. Cast a provisional ballot if their registration or identity is in question.
- 7. Written instructions to use when voting and upon request, oral instructions in voting from election officers.
- 8. Vote free from coercion or intimidation by elections officers or any other person.
- 9. Vote on a voting system that is in working condition and that will allow votes to be accurately cast.

(Section 101.031 Florida Statutes)

### **Voter's Responsibilies**

### Each registered voter in this state should:

- 1. Be familiar with the candidates and issues.
- 2. Maintain with the Election Office, a current address.
- 3. Know the location of their polling place and its hours of operation.
- 4. Bring proper identification to the polling station.
- 5. Be familiar with the operation of the voting equipment in their precinct.
- 6. Treat election workers with courtesy.
- 7. Respect the privacy of other voters.
- 8. Report any problems or violation of the election laws to the Supervisor of Elections.
- 9. Ask questions if needed.
- 10. Make sure their completed ballot is correct before leaving the polling station.

**NOTE TO VOTER:** Failure to perform any of these responsibilities does not prohibit a voter from voting.
